SCHOOL FEE POLICY & PAYMENT GUIDELINES

1. Fee Payment

- The annual school fee shall be paid in two installments.
- First Installment: On or before the first day of the First Term.
- Second Installment: On or before the first day of the Second Term.
- Fee due dates are mandatory and non-negotiable.

2. Discounts

- Full Fee Payment: ₹ 5,000/- discount if the entire Annual Fee is paid before the First Term begins.
- Sibling Discount: If siblings study simultaneously, a ₹ 5,000/- annual fee discount is applicable to each student. Subject to timely fee payment.

3. Personal Expenses

- ₹ 25,000/- must be paid separately at the time of reporting.
- This amount is for student personal and school-related expenses.

4. Imprest Account & Additional Charges

- The imprest (accountable) amount shall be maintained as instructed by the school. Charges towards excursions, tours, competitions, external programs, and other outside activities are excluded from the regular School Fee.
- In the event that the initial imprest amount of ₹ 25,000/- is exhausted or exceeded, parents/guardians shall be notified and the required additional amount must be remitted as per the school's communication.

5. Late Payment

Payments not received by the prescribed due date shall attract a late fee penalty, as determined by the school's fee regulations. Continued delay may result in loss of concessions or restriction from activities.

6. No Refund

The school maintains a strict no-refund policy. Once fees are paid, they are final and non-refundable, regardless of withdrawal, transfer, discontinuation, medical reasons, or any other circumstances.

7. General

- Fee payment implies acceptance of all school rules and policies.
- The management reserves the right to revise the fee policy when required.
